*GOVERNANCE

The EBRCOA is mandated by the Older Americans Act (OAA), to respond to the needs of Americans aged 60 and over in the local community with the goal of keeping seniors living independently in their own homes. An Area Agency on Aging (AAA) plans and provides social services and nutrition services for elders, and support for caregivers.

Governance

The East Baton Rouge Council on Aging (EBRCOA) is both an Area Agency on Aging (AAA) and a Council on Aging (COA). EBRCOA is governed by the Administration of Aging which is responsible for enforcing the Older Americans Act and the Governor's Office of Elderly Affairs (GOEA) which manages the Louisiana State Plan on Aging. The EBRCOA is allocated funding through the Area Plan which is a grant application the agency submits to the GOEA for the period of fiscal years 2022 – 2027.

Performance Expectations

The Governor's Office of Elderly Affairs (GOEA) has provided the following performance indicators as a means of measuring COA performance.

- Increase the number of older persons who have access to an integrated array of health and social supports;
- Increase the number of older persons who stay active and healthy;
- Increase the number of families who are supported in their efforts to care for their loved ones at home and in the community; and
- Increase the number of older people who benefit from programs that protect their rights and prevent elder abuse, neglect, and exploitation.

- Facilitate leadership in developing and improving transportation options for the elderly in the Public Service Area and;
- Providing assistance with applying for benefits and programs.
- The seventh and final goal is to educate consumers on services provided by Ombudsman and display and distribute flyers provided by GOEA, and provide opportunities for Ombudsman to speak to staff and clients about the service to promote awareness.





